

Hoover's Public Library/Academic Subscription Terms and Conditions

1. Copyright/Use.

A) The information available through the Service is the property of Hoover's, Inc., or its licensors, and is protected by copyright and other intellectual property laws. The following copyright notice: "Copyright © 2006, Hoover's, Inc., ALL RIGHTS RESERVED" along with Hoover's logo that appears above, shall not be removed from any print-outs from the Service; any references will follow normal standards of scholarly attribution. You are granted a nonexclusive, concurrent, non-transferable, limited license to access the Service. Access to the Service is limited to the number of simultaneous users specified in your order. In the event the account reaches the concurrency limit, Hoover's reserves the right to deny access to any and all users in excess of the number of simultaneous users specified on the order. Access to the Service for a Public Library is via IP address range only, and is intended for in-library use only. Access to the Service for an Academic institution is intended for in-library use via secured remote access. Subscriber agrees to make reasonable efforts to inform authorized users that they may not systematically reproduce, photocopy, distribute, or disseminate information received through the Service for any commercial/profitable purpose; furthermore, authorized users may not retransmit, sell, publish, broadcast, or circulate the information received through the Service to anyone else without the express prior written consent of Hoover's, Inc.
